Social Media and Cyber Safety Policy



Policy Introduction

This policy applies to Men's Netball NSW (MNNSW) members and affiliates.

The Policy aims to ensure that our core values, reputation and positive behaviours are maintained at all times. In addition, that all individuals involved with our Association are treated with dignity and respect, and are safe from harm and abuse.

This policy sits alongside MNNSW's other policies. It is important that you familiarise yourself with MNNSW's other policies.

Policy Details

All use of Social Media platforms which are directly governed by, or relate to the operations of, MNNSW and affiliated Associations, will be regulated by the MNNSW Social Media and Cyber Safety Policy (this policy) and relevant Codes of Behaviour.

The policy will apply when using social media as:

- a) A designated member representing MNNSW; and
- Any person posting content on social media platforms in relating to MNNSW that might affect our product, service, events, sponsors, members or reputation.

MNNSW welcomes anyone express their views, comments, ideas and insights about MNNSW, its programs and activities.

At the same time, this should be done to ensure individuals show courtesy and respect to others and must not use our social media channels to abuse others, expose others to offensive or inappropriate content, or for any illegal purpose.

Acceptable Use

When using our social media channels, please ensure that the following occurs:

- Protect your personal privacy and that of others by not including personal information about yourself or others in your posts to our social media channels (for example, email addresses, private addresses or phone numbers);
- Represent your own views and not impersonate or falsely represent any other person;
- Keep your posts relevant to MNNSW;
- Are not abusive and do not harass or threaten others;
- Do not make defamatory or libelous comments;
- Do not use insulting, provocative or hateful language;
- Do not use obscene or offensive language;
- Do not post material that infringes the intellectual property rights of others;
- Do not post multiple versions of the same view or make excessive postings on a particular issue;
- Do not promote commercial interests in your posts;
- Do not include harmful or offensive internet addresses or links to websites, or any email addresses in your posts.

Participants may face disciplinary action for sending inappropriate electronic communication or posting online content or comments that harass, offend, intimidate or humiliate another participant.

Under certain circumstances, cyber bullying (e.g. bullying that is carried out through an internet service such as email, a chat room, discussion group, instant messaging or website) is a criminal offence that can be reported to the police.

In addition, participants who publish false or misleading comments about another person in the public domain (e.g., Facebook, YouTube, Instagram or Twitter) may be liable for defamation.

Right to Remove Posts and Block Offenders

MNNSW has the right to enforce this Acceptable Use Policy at its discretion.

MNNSW administration may remove any posted messages that it considers to be in breach of this policy and will block repeat offenders.

Photographs

Photographs taken by MNNSW or its agent(s) of a child or yourself in attendance at a MNNSW Event/Function, may be utilised for any legal/appropriate purpose whatsoever, including (but not by way of limitation) illustration, promotion, advertising, trade, etc.

Such photographs may be published in any medium and may be labelled with the name of the person/s in the photograph and the event at which the photograph was taken.

When using photos on social media channels, please ensure that you:

- Avoid naming the child. If this is not possible avoid using both a first name and surname.
- Avoid displaying personal information such as residential address, email address or telephone numbers if images are being posted on websites or distributed in publications.
- Do not display information about hobbies, likes/dislikes, school, etc. as this information has the potential to be used.
- Only use appropriate images of the child, relevant to the sport or activity, and ensure that the athlete/child is suitably clothed. Images of athletes participating in sports or activities that involve minimal clothing or unusual body positions/poses could potentially be misused. The age of the child is another factor to consider when deciding if the image is appropriate.
- Reduce the ability for direct copying of pictures from a website to another source (i.e. disable the 'right mouse click' function).
